

FEE SCHEDULE



Effective January 1, 1989

- I. **THREE-YEAR LICENSE.** Three annual payments for VMCENTER II. The annual payments shall be due upon delivery and the first and second anniversary dates of delivery.

Annual renewal for the fourth and subsequent years is automatic, unless Licensee cancels in writing, at least thirty (30) days prior to the license expiration date. The license fee for each renewal year is twenty-five percent (25%) of the prevailing permanent license fee for the CPU model on which VMCENTER II is installed.

- III. **MONTHLY LICENSE.** The monthly license fee is eight percent (8%) of the prevailing permanent license fee. Fifty percent (50%) of monthly license fees paid may be credited towards a conversion to a three-year or permanent license. The maximum credit accrual is 50% of the applicable prevailing license fees.

- IV. **CPU GROUP LISTING.** This listing includes IBM computers only. Prices of licenses for IBM computers not listed or non-IBM computers will be quoted upon request.

- V. **DOCUMENTATION.** One set is included with each system license. Additional copies of documentation and/or listing files are available as shown on the current Publications Order Form.
- VI. **UPGRADES.** If a three-year license (or any renewal thereof) is being transferred to a CPU model in a higher group (upgraded), a new three-year license is started, with the new license fee reduced by the paid but unused portion of the old license fee. If a permanent license is being transferred to a CPU model in a higher group (upgraded), the difference between prevailing permanent license fees is the upgrade fee.
- If a monthly license is being transferred, the increased fee will apply to the first monthly payment following the month in which the transfer took place.
- VII. **PRODUCT SUPPORT AND ENHANCEMENT (PS&E) PLANS.** There is no charge for a period of one (1) year following the date of delivery of the product. Until January 1, 1990, the PS&E fee for components and individual products is 15% of the permanent license fee shown in Section II above and the PS&E fee for VMCENTER and VMCENTER II is 21% of the permanent license fee in Section II.
- VIII. All license fees and other terms contained in this Fee Schedule are subject to change by Licensor without notice, except PS&E fees in Section VII, which may not be changed prior to January 1, 1990.
