Ameritech offers special cellular pricing program to employees

Ameritech Cellular again is offering a special pricing program for Ameritech employees and retirees. Effective now until September 30, 1993, employees and retirees in areas served by Ameritech Cellular and its CyberTel subsidiary (see story on page two) may order one to six cellular lines at reduced service rates. Billing for all lines ordered under this program must be in the employee's or retiree's name.

Details of the Ameritech Special Pricing Program

- Monthly access charge: \$11.75
- Peak hours price per minute: 27 cents
- Off-peak hours price per minute: 12 cents
(Peak and off-peak hours vary by market)
- Establishment fee: waived
- Free features available: Custom Calling features, Detailed Billing, Mobile Message Service.
- Term: One-year contract (Rates are fixed during the term of the contract. Service continues after contract expires, but rates may change.)
- Disconnect fee: \$150 per line -- if disconnected before one-year contract expires.

Current cellular customers

If you have Ameritech cellular service under another plan and would like to transfer to the Ameritech Special Pricing Program, fill out the form on page four of this Bulletin and mail it to the address listed. If you have more than one line and would like to transfer to the program, please photocopy the form and fill out one form for each

line you are transferring.

New cellular customers or additional lines

You can sign up for new service or additional lines by going to an authorized Ameritech Cellular agent (listed on pages two and three of this Bulletin). Fill out the attached form and show the agent a company photo I.D. Please photocopy the authorization form and fill out one form for each new line you are ordering.

Employees in CyberTel markets in southern Illinois can obtain both the order form and authorized agent list from their supervisors.

Equipment

Ameritech Mobile Sales and Service Centers are offering a \$100 rebate on three Motorola phones as part of the Ameritech Special Pricing Program for employees.

The AC2250 tote phone, normally \$188, will be sold for \$88. The AC715 handheld phone will cost employees \$117 after the rebate. The \$349 PCH (flip phone) will sell for \$249.

Other Ameritech agents are not participating in this equipment offer, but may be offering other equipment at special prices.

Employees must live in Ameritech cellular service area to be eligible for Special Pricing program

The Ameritech Special Pricing program is available to Ameritech employees who live in the areas in which Ameritech provides cellular service. Because Ameritech does not have licenses from the Federal Communications Commission (FCC) to provide cellular service in all the same areas where Ameritech Bell companies provide landline telecommunications services, not all employees will be able to take advantage of this program.

Ameritech currently offers cellular service in the following markets. Ameritech employees who live in these markets are eligible for the Ameritech Special Pricing Program for cellular services:

Illinois -- Metropolitan Chicago, Kankakee, Morris, Joliet, Springfield, Champaign, Danville, Bloomington, Decatur, Effingham, Lincoln, Casey, Mattoon, Vandalia. (This offer is available to employees in the East St. Louis area through Ameritech's CyberTel subsidiary.)

Indiana -- Gary, LaPorte, Michigan City.

Wisconsin -- Milwaukee, Madison, Janesville, Beloit, Portage, Racine, Sheboygan, Kenosha, Lake Geneva, Watertown, Wisconsin Dells.

Missouri -- St. Louis and much of the rural portions of the state.

Important: When you select the Service Product indicated above, and sign this Agreement, you agree to a one-year minimum service period (the "Minimum Term") with Ameritech Mobile Communications, Inc. ("Ameritech"). The Service Rates and Charges in effect at the beginning of your initial Minimum Term will remain in effect until the end of that Minimum Term. If, **after you complete the Minimum Term governed by this Agreement**, you change to any Service Product which is subject to a different Minimum Term, you are obligated **only** for the new Minimum Term.

Your Minimum Term obligation is not affected by a change in Cellular Number. You may change to any other Service Product during your Agreement provided that you remain on Ameritech Cellular Service for your entire Minimum Term, except that you may not change to our Vacation Plan until you have purchased our Service for at least six (6) months. If, after your Minimum term, you decide to change to a Service Product which is not subject to a longer Minimum Term, you are still subject to the standard one-month Minimum Term for our Service.

IMPORTANT: If you do not remain on Ameritech Cellular Service for the duration of your Minimum Term, **then you will be responsible for a \$150 Early Cancellation Fee** per cellular number, in addition to all other outstanding charges on your account. All lines must be in the employee's name to be eligible for this Service Product. **Six line maximum** per eligible customer/employee.
